City of Bunbury Constitution Clause 7.3(f) A Member suitable for Life Membership is any natural person who has rendered distinguished service to the Club and surf lifesaving, where such service is deemed to have assisted the advancement of the Club and surf lifesaving in the City of Bunbury.

In addition to this, the following conditions and criteria in Policy Statement Number 2.2 'Life Membership' shall be used by the Life Membership Committee, Board and General Membership in the assessment of whether a nominee should be awarded with Life Membership;

- 1.1. The voluntary service rendered and the achievements during that period must be considered as distinguished.
- 1.2. Consistent, sustained and dedicated service or achievement and exemplary contribution that is beyond what is expected of Club members.
- 1.3. The service and achievement must primarily be for the benefit and/or advancement of the Club. Service and achievement within SLSWA or SLSA may also be considered as a contribution to the person's nomination.
- 1.4. The contributions made by the nominee to the Club can be wide and varied and all of these must be considered. The number, types of positions, demands of each position and the period for which they were held should all be considered.
- 1.5. A competitive record including local, State and/or National representation may also be considered as contributing to the nomination for Life Membership.
- 1.6. The nominee shall have shown to have abided by the Code of Conduct of SLSA, SLSWA and the COB SLSC. The nominee must have exhibited professional, ethical and positive conduct during their Membership of the Association.
